

TravelOne Credit Card: Terms and Conditions for Introductory Offer

- 1. This Offer is brought to you by The Hongkong and Shanghai Banking Corporation Limited, India ('HSBC'). Any participation in the said Offer is voluntary.
- 2. This Offer is only applicable to new HSBC TravelOne Primary Credit Cardholders (hereinafter referred to as 'Cardholders'), who apply for a HSBC TravelOne Credit Credit Card between 1 December 2024 to 31 December 2025 ('Offer Period') and the card is issued subsequently.
- 3. Credit Cardholders who have not repaid their minimum payment due within 30 days of their payment due date as mentioned on the credit card statement, will not be eligible for the Offer.
- 4. The offer is limited to Credit Cardholders with updated KYC details with the Bank.
- 5. Cardholders who qualify for the below criteria become eligible for offer rewards:
 - (i) Open a new HSBC TravelOne Credit Card Account and
